I remember interviewing him and thinking, not only did he have the right qualifications to work in the Weatherization program; I also felt he had the attributes and qualities to be someone who could do anything he set his mind to, and that is exactly what he did. He did a wonderful job as a housing specialist and then an opportunity presented itself for him to move to the grant writing and administration side of the Agency. He took this task on with gusto and what was so special about him in this role, was that he was always looking to expand his knowledge or look for new and exciting opportunities for the Agency. Nathan was never one to just accept the status quo. He wanted to know the how and the why and his inquisitive side led to new

He applied for the position and was overwhelmingly the choice given his work ethic and abilities. In that position, he did an outstanding job. All the staff saw Nathan as a rising star and destined for excelling, whether it was at the WIRC or elsewhere. Anyone would be proud to call him a friend, co-worker or colleague.

I spent a lot of time with Nathan over the years and before my retirement. He would come to the main office and ask how my day was going. That is something that he did with every one of the employees at WIRC. His smile and kindness to care and ask how someone was doing touched everyone. One of my fondest memories of Nathan was the day he took me flying last fall. It was a rather windy, bumpy day and Nathan kept apologizing because of the turbulence. I told him not to worry because I felt like I was on a roller coaster, albeit 1700 feet in the air and just the ground below, but this was fine. My husband Tim and friend Tracy in the back seat weren't having as much fun as I was though since I was in the front seat and they apparently were bearing the brunt of the rocking and rolling. At one point, Nathan turned to me and asked me if I wanted to fly the plane. I immediately said yes and he turned it over to me which certainly took a lot of trust on his part since I had never done anything like this before. Granted, it was only for about five minutes or so, just long enough for me to further cause rocking and rolling for the backseat passengers, until I told Nathan he better take back the controls. We both had fun and I know Nathan relished the fact that I had enjoyed this flight so much. This memory will always remain special to me.

Nathan was a kind and gentle soul, with a big and generous heart. Those who knew him well have shed many a tear over his loss. Those that didn't know him well but who he might have come in contact with him have commented that any time they saw him, his caring and compassion would always shine through by his pleasant and heartwarming smile and demeanor. Nathan was very special for all of the kindnesses he shared and for being the very special

person that he was.

Nathan is missed by so many aside from his immediate family including his WIRC family, his family at the Transit Facility and all that he touched in this community, the region, the state and beyond. Nathan's passing will remain heavy on our hearts for a very long time to come. We have all lost with Nathan's passing; this bright and shining star of a young man, who has left us far too soon.

WIRC ANNOUNCES GRANT AWARDS FOR LOCAL IMPROVEMENTS

Through grant applications prepared and submitted by Western Illinois Regional Council (WIRC), six communities have been awarded Community Development Block Grant (CDBG) funds by the Illinois Department of Commerce & Economic Opportunity. Five of the awarded grants are for public infrastructure and one grant is for housing rehabilitation.

Public infrastructure CDBG grants were awarded to the following communities: the City of Abingdon in Knox County (\$450,000 for water system upgrades); the City of Bushnell in McDonough County (\$500,000 for a new well); the City of Farmington in Fulton County (\$500,000 for sanitary sewer upgrades); the City of Macomb in McDonough County (\$500,000 for a water main replacement); and the City of Monmouth in Warren County (\$500,000 for a water main replacement).

The City of Colchester in McDonough County was awarded a \$500,000 CDBG housing rehabilitation grant.

WIRC, based in Macomb, serves its member communities in the six-county region of Fulton, Hancock, Henderson, Knox, McDonough and Warren counties. WIRC Community Development staff assists local governments in addressing public infrastructure and housing needs by utilizing state and federal funding opportunities. WIG & TURBAN PROGRAM AIMS TO HELP CANCER PATIENTS



In order to try to help cancer patients feel better about their situation, WIRC-CAA's Wig & Turban Program has a variety of wig styles available for them to choose from.

Receiving a cancer diagnosis is a life-changing, emotional event. Chemotherapy often saves lives, but the treatment can cause hair loss, among other side effects. With the rising costs of healthcare, purchasing a wig or turban may not be financially feasible for some individuals. In order to try to help cancer patients feel better about their situation, WIRC-CAA's Wig & Turban Program provides free wigs and turbans to individuals suffering from this terrible disease.

"A person may have a lot of money going out for treatment, and being able to get a wig and turban for free helps take some of the pressure off," said Program Coordinator Teresa Cadle. "Losing your hair is one of the hardest parts of chemo."

The only eligibility requirement for the program is the individual must have a cancer diagnosis; no paperwork is required. Interested individuals are asked to make an appointment so they can browse in privacy. To obtain an appointment, call WIRC-CAA at (309) 837-2997 between 8:00 a.m. and 4:00 p.m., Monday through Friday.

The Wig & Turban Program has been in place at WIRC-CAA for over 20 years, and it relies on donations from the public in order to provide these items to those in need. Monetary donations can be mailed or brought to: WIRC-CAA, 223 South Randolph Street, Macomb, Illinois 61455. The program also accepts new and/ or gently used donations of wigs; turbans; brassieres; and silicone breast forms. At this time, the program is most in need of turbans.

WIRC's Community Action Agency department provides efficient and diverse human services to help individuals and families help themselves. WIRC-CAA offers a wide variety of programs designed to help those in need, including a clothing center, an energy assistance program, and a food pantry program. COLLEGE SCHOLARSHIPS AVAILABLE THROUGH WIRC-CAA



WIRC-CAA has several \$2,000 scholarships for individuals desiring to further their educational training through an Illinois community college, vocational school, college, or university.

Applicants must be a resident of Hancock, Henderson, Knox, McDonough, or Warren counties. Scholarship recipients may apply the \$2,000 award towards tuition and fees, textbooks, supplies, or campus room and board.

Applicants will be evaluated on the basis of financial eligibility, scholarship potential, commitment to civic affairs, career goals, and personal interviews.

Beginning February 17, applications became available from high school guidance counselors, college financial aid offices, the WIRC website at wirpc.org, and the WIRC office, 223 South Randolph Street, Macomb. Completed applications must be received at the WIRC office by 4:00 p.m. on March 31, 2020. TRADE SCHOOL SCHOLARSHIPS AVAILABLE

WIRC-CAA has scholarship funds available for individuals trade. studying vocational a Successful applicants will provided financial assistance towards the cost of tuition, fees, and books to complete a specified training program through to certification. Potential fields of study include, but are not limited to: automotive technology; commercial driver training; cosmetology; computer information systems; HVAC; plumbing; welding; or another allied trade through an Illinois vocational-technical program.

As this is a grant-funded scholarship requiring eligibility determination, successful applicants must be a resident of Hancock, Henderson, Knox, McDonough, or Warren counties and be a member of an income-eligible household. Successful applicants have the option to take classes at academic institutions outside of the five-county area. Income eligibility will be determined by WIRC-CAA staff during the application process.

To apply, prospective applicants must send a cover letter to Western Illinois Regional Council, 223 South Randolph Street, Macomb, Illinois, 61455, detailing the following information: why they are interested in this scholarship; the vocational trade they plan to study; where they plan to study the vocational trade; the timeframe (as determined by the school) that they are required to complete their chosen program; the expected cost of completing their studies; how they plan to pay their bills (rent, food, etc.) while studying a vocational trade; their transportation needs while they attend classes; and employment opportunities they plan to pursue after graduation.

5K TO BE HELD IN HONOR OF LOCAL NURSE

Kathy Simmons was compassionate nurse at McDonough District Hospital, a resident of Hancock County, and mother of three children. On March 26, 2003, she became a fatal victim of domestic violence by the hands of her husband of 25 years. The Kathy Simmons Memorial 5K Walk/Run/ Roll, sponsored by WIRC-CAA Victim Services, is held every year in memory of Ms. Simmons and in support of survivors of domestic violence.

Domestic violence is a daily reality for many people in Macomb and the surrounding area, as it was for Ms. Simmons and her family. In 2019, Victim Services assisted 445 clients, including 67 children, who were affected by domestic violence. On a national scale, the CDC reports that nearly 1 in 4 women and 1 in 7 men have experienced severe physical violence by an intimate partner (e.g. the abuser punched, kicked, and/or threatened the survivor with a weapon). Additionally, the U.S. Department of Justice found that 1 out of 15 children have witnessed intimate partner violence. While these

statistics are devastating, Victim Services believes it is possible to stop the cycle of domestic violence, and that events like the Simmons 5K can raise awareness and show unity against this sometimes deadly crime.

The 2020 event will be held on Saturday, May 2 at Citizens Bank Plaza, 220 South Randolph Street, Macomb. Check-in begins at 7:30 a.m., and the event starts at 8:00 a.m. Kiryn Evans, Ms. Simmons' daughter and an advocate for domestic violence awareness, plans to give a brief presentation before the race. All age groups and abilities are welcome. Walkers and non-competitive individuals are encouraged to participate. Dogs on a leash are also welcome.

Those who want to participate can register online at https://conta. cc/39ovU18, call Victim Services at (309) 837-6622, or pick up a

paper registration form at Western Illinois Regional Council, 223 South Randolph Street, Macomb. The registration fee is \$30 per person if paid by April 7, 2020; the fee increases to \$35 per person if paid after April 7. T-shirts are guaranteed to those who register on/before April 7. Ribbons will be awarded to the top male and female winners following the 5K. Complimentary healthy snacks and drinks will be available to participants.

Tentatively starting at 9:00 a.m., a silent auction/raffle and a free outdoor yoga class are scheduled near the finish line at Citizens Bank Plaza. Those who wish to show their support without participating in the 5K are encouraged to take part in those activities.

Victim Services provides free and confidential services in a safe environment with knowledgeable staff members who are ready to provide emergency services, advocacy, counseling, professional training, and public education. All services are provided free-ofcharge to survivors of domestic and/or sexual violence. LOCAL PROGRAM HELPS OFF-CAMPUS COLLEGE STUDENTS WITH THEIR ENERGY BILLS



College can be an exciting time for many students, but for some it can also include economic struggle. WIRC-CAA, based in Macomb, wants college students to know they have programs that can help them. One of their programs, the Low Income Home Energy Assistance Program (LIHEAP), can help income-eligible students living off-campus in Hancock, Henderson, McDonough, and Warren counties with paying their energy bills.

A household may qualify to receive energy assistance if the gross income for all household members for a 30 day income period does not exceed the following levels: \$1,561 for a one-person household; \$2,114 for a two-person household; \$2,666 for a three-person household; \$3,219 for a four-person household. For each additional household member, add \$553.

Persons applying for assistance must provide the following information to document eligibility for the program: proof of gross income for all household members for a 30 day income period; a complete and current copy of the heating and electric bills; and social security cards for all household members.

The general low-income population is also welcome to apply for LIHEAP.

To obtain an appointment, call WIRC's Community Action Agency department at (309) 837-2997. Local outreach sites are available for filing an application. This season's program ends May 31, 2020.
